### A CONDITIONS OF NOMINATION

1. The Board of Trustees currently has one (1) vacancy for a pensioner representative trustee and serves for a 4 years cycle.
2. You may not nominate or second yourself. No person may nominate or second the same person twice.
3. The nominated candidates should be seconded by a minimum of twenty (20) RFLAUN pooled pensioners.
4. Eligible nominee must:
  - Be older than 18 years.
  - Be a Fund Pooled Pensioner.
  - Appear on the verified pensioners list.
  - Must meet the requirements set out in the Fit and Proper Person Policy of the Fund. The eligible Trustees must complete the Fund's Fit and Proper Person Policy questionnaire by completing REF 7 Form and must be willing to consent to the vetting process of the Fund by completing REF 6 Form.
  - Must be willing to provide a Certificate of Conduct from the Namibian Police valid for six (6) months and credit check report.
